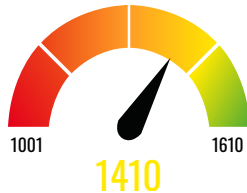

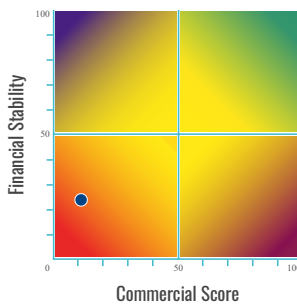

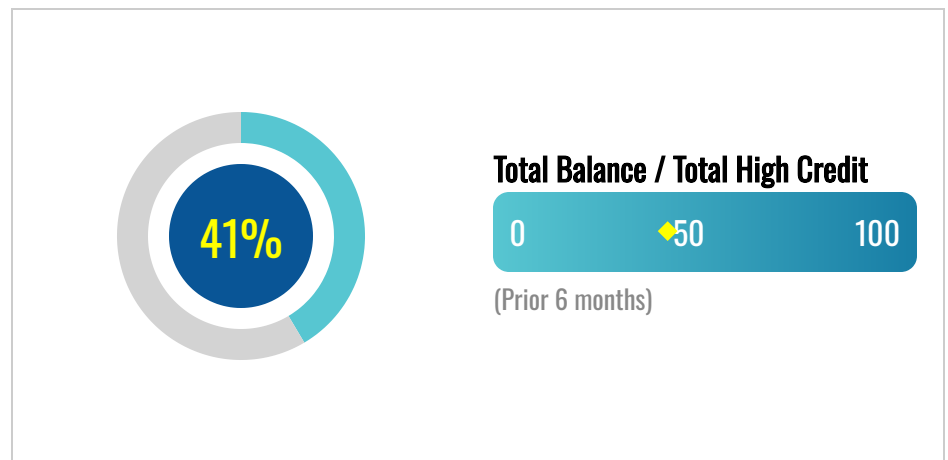

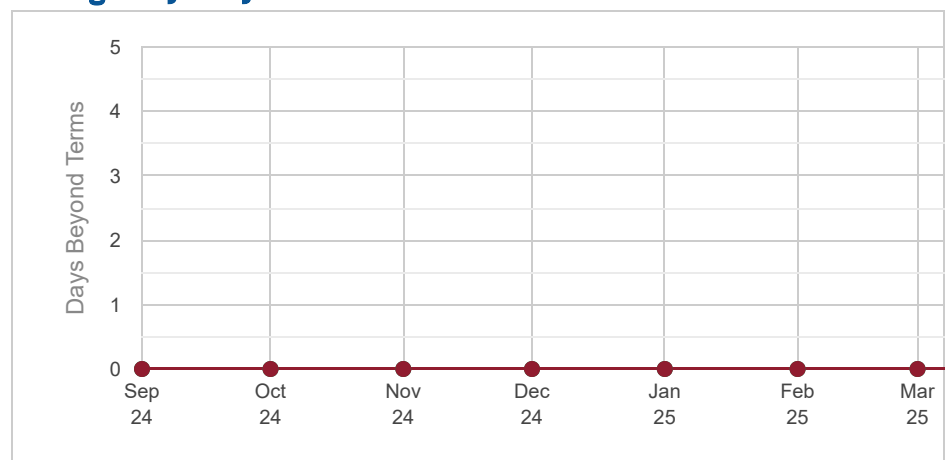
Credit Utilization

Average Days Beyond Terms

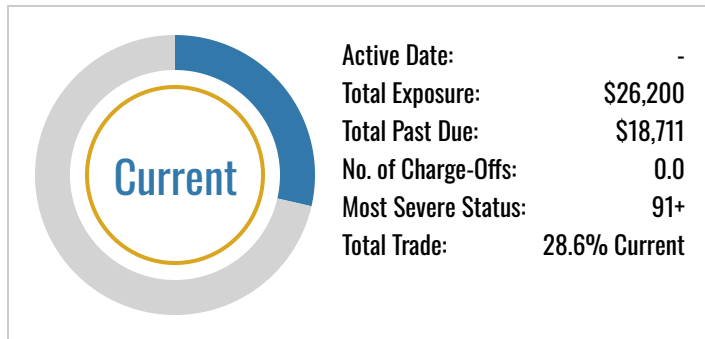

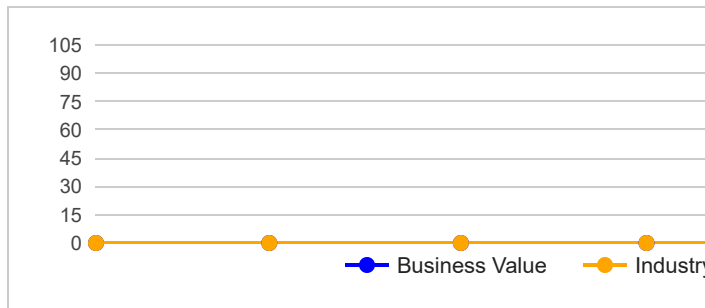

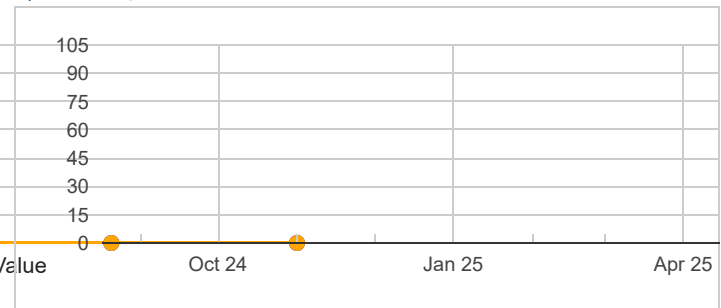
Six Month DBT Trends
